David Brooks puts a new spin on the genesis of over-incarceration-it's all the prosecutors fault! This column appeared in the NYT on Tuesday. NDAA is preparing a response: http://www.nytimes.com/2015/09/29/opinion/david-brooks-the-prison-problem.html?_r=0

The federal sentencing commission set a review of all people incarcerated to find those eligible for early release as earlier efforts revealed a dearth of folks in the low level drug offender category. They are now looking at 16,000 people system wide, some of whom have a criminal history in the level 4-6 which is not necessarily low level, non-violent folks.

Meanwhile, the criminal justice reform bill is getting dropped in the Senate today: it will likely go to markup the week of 10/22. I will be forwarding a summary of the 12 major components from Nelson Bunn who has been at the staff table on behalf of the prosecutors during drafting but there are many, many challenging things that remain in the bill despite his best efforts. DOJ is opposing but the bill will likely pass committee. Law Enforcement will likely oppose but are holding their comments until they see the final draft.

There is also an asset forfeiture bill that would make a major change to equitable sharing, the Safe Campus Act that would allow LE to handle rape investigations (NDAA Supports) and an International Meghan's Law to track sex offenders coming into our country and alerting destination countries of those that travel away from the US (Support)

Dear Attorney General Brnovich:

My name is Mark Weiss and I am attorney in Scottsdale. I have been in AJ Moss's fantasy football league for the last three years or so after taking about a 2 year hiatus, the same league but a different division than you were in. AJ worked at our firm as a Patent agent before going to law school. (I am also a Republican and voted for you in both the primary and the general election)

Anyway, I wanted to pass on some information to you regarding Gustavo (Gus) Nunez who is scheduled for trial next year. You were quoted in the below article regarding I the sentencing of Ilda Garcia who was Gus Nunez assistant.

I and my firm was sued back in 2007 in a lawsuit that Russ Piccoli and Chuck Price (who were at Mariscal Weeks) filed on behalf of Greg Paterno, his company Microgroup and

3 other employees for Microgroup. Russ Piccoli and Chuck Price are liberal lawyers who allowed their clients to present false testimony and forge documents. The case went to trial in February of 2011. Here is how it ties in to Gus Nunez. I started NJOY, an electronic cigarette company and Microgroup was a contract manufacturer in Scottsdale. I had handled a matter for Paterno in the spring of 2006 and we were looking to get our product manufactured in the US instead of China. We had a 40000 unit order and Paterno claimed he could make it for under \$15 a unit and at the time we were paying our Chinese manufacturer \$20 plus shipping. The first meeting regarding NJOY was around March 19, 2007 and by early April, Paterno claimed he could start making the 40000 units by June 1st and for the much lower price. NJOY gave Paterno the 40000 unit order and gave him \$100000 in April of 2007 to begin working on it by reverse engineering and making a working product. Paterno's failed to deliver in June, July or August and after paying him an additional 53000 plus in late August to deliver by September 7, 2007, Paterno failed to deliver any units that worked.

Paterno then turned around and sued NJOY (NJOY changed its corporate name from Sottera which was the company name until about 3 years ago) two other directors at NJOY, Farley Weiss, my firm and myself for millions of dollars based on NJOY's projections. We found out through a Canadian by the name of Barry Vogel that invested in NJOY many months later that Gus Nunez, whose company in Tucson was called Nutec that sold products to Barry Vogel company in Canada, that in August of 2007, Nunez approached him in Canada about investing in a new electronic cigarette business that his friend Greg Paterno was working on. Vogel eventually met Paterno and Nunez in Arizona and happened to ask a friend of his about the investment that turned out knew my brother Farley and told Barry that he knew the Weiss's were involved in a similar product and that is how we found out that Greg Paterno was trying to compete with us while delaying the manufacture of our product.

During the litigation, Paterno and Nunez denied ever trying to compete until after the relationship ended in September of 2012 which was false testimony. They hid emails and even lied under oath about emails that showed they were competing by claiming it was for another product unrelated to NJOY. During the litigation in an attempt to create damages, Paterno submitted an invoice from NUTEC (Gus Nunez's company) of over \$32000 (for batteries and battery chargers) and bank statements with four payments made by direct deposit or wire allegedly to pay this \$32000 invoice. The four payments totaled \$30 less than the total amount and the invoice. The account of the receiving party was redacted.

NJOY had provided Paterno with the Chinese manufacturers that made the batteries which while looking like AAA batteries were 3.6 or 3.7 volts and only made in China. Paterno had forged the invoice and matched up payments that Microgroup made to other companies and claimed they were made to Nutec. Before Greg Paterno was deposed for the first time and after the Nutec invoice had been submitted, I had called Gus Nunez who Barry Vogel had advised had invested with Greg Paterno in his

Electronic cigarette project and lost a lot of money since it never got off the ground and that Gus Nunez wife was divorcing him which Barry Vogel thought was because of the lost investment with Paterno. Nunez did not want to cooperate and when Paterno was deposed he claimed that the Nutec invoice was mistakenly included by an employee by the name of Tandra Billings when it was produced three weeks earlier.) We found Tandra Billings and found out that she had moved out of Arizona 9 months before Paterno claimed she inadvertently included the invoice in their document production. Paterno testified for 35 pages of testimony that he should not have included the invoice because after the relationship with NJOY ended, Nutec was able to resell the batteries to another customer and give him a credit back for the \$32000 plus.

NJOY subpoenaed Nutec for its records to substantiate this incredible story and then Paterno made corrections to his deposition testimony (I am sure at the request of Price and Piccoli) to wipe out 35 pages of testimony and disregarding the alleged payments made by Microgroup to Nutec that Paterno claimed were made, changed the story to a second lie. This lie was that Paterno wanted a new billing program and asked Nutec for an invoice to show him their billing program. Nutec eventually produced the same invoice that Paterno produced but their version had all sorts of handwritten notes. See the attachment. The first page is the clean fake Nutec invoice and the second one is the fake nutec invoice that the Nunez brothers produced with the handwritten notes claiming it was a QuickBooks program. This invoice was not created on Quickbooks but was created on Microsoft Excel and the number 39303 was suppose to be the date August 9, 2007 (you can confirm this on Excel by opening a file and clicking the function key for date and having it convert to a number and typing in August 9, 2007 and it comes out to 39303. Paterno did not correct the date field and had typed in August 9, 2007 which was before his relationship with NJOY ended but he did not format the cell correctly and didn't notice that it changed the date to the number 39303. A secretary in our office figured it out and I even confirmed it again in writing this email by opening an Excel spreadsheet. Oscar Nunez, Gus brother and partner, actually testified in trial that this number 39303 was Quickbooks bypass code to get past the date field since a correct date needs to be inserted in Quickbooks before you can get to the next part of the invoice.

Judge Rea, a liberal pro plaintiff judge did not take any action against Paterno or the Nunez brothers for their blatant perjury and fraud on the court. We settled the case before the Jury came back. Perhaps if Judge Rea had reported Greg Paterno, Gus Nunez and Oscar Nunez to the Attorney General's office for criminal prosecution for perjury, the injuries that Gus Nunez caused could have been prevented. Chuck Price and Russ Piccoli ended up doing the case on contingency and participated in the fraud on the court.

I am looking forward to Gus Nunez getting convicted and going to jail. There was so much more in our case that Paterno did and that Chuck Price and Russ Piccoli were aware was false. Unfortunately it is my experience that judges in Arizona like Judge

Rea have lost a sense of outrage and think perjury is acceptable.

Late yesterday afternoon, the IACP participated in a conference call with the U.S. Department of Justice (DOJ). During that call DOJ announced that, effective immediately, all new equitable sharing payments to state and local law enforcement agencies through the federal asset forfeiture program will cease for the foreseeable future. This decision was a result of the passage of the Consolidated Appropriations Act of 2016 (H.R. 2029), which was signed into law on December 18, 2015. The Consolidated Appropriations Act made major rescissions from the federal asset forfeiture fund to pay for other programs.

We want to make clear that neither the IACP, nor any of our law enforcement partners, were consulted regarding this announcement. The position of the IACP is this decision is detrimental to state, local, and tribal law enforcement agencies and the communities they serve.

We will work with DOJ, the administration, and the U.S. Congress to do what we can to address this situation.

This is clearly a "bait and switch" since \$49 barely covers an 18 gallon tank of gas.

An hour later they were quoting \$175 with tax and fuel. I do not believe they will rent at that price either.

Most guests have told me that when they actually get there they are told that "those skis are gone".

I am still not sure what the long term solution is and ██████████ affects my business less than some of the other local rental companies, but the primary concern is that this type of operation reflects very poorly on all of the jet ski rental operators that are trying to run an honest business.

In addition, the most common thing we hear is "why doesn't the city put a stop to this?".

We have been giving customers an honest experience for over 24 years and as both a business owner and member of the community, I would like to be part of the solution and not just the complaint committee. I do believe the city needs to take an interest in any dishonest or unethical business practices that occur in the city limits. Many of the people being scammed are out of towners that just go home and consider it a lesson learned. They don't know where or how to file a complaint.

I believe an information gathering operation may be an option that could include customer exit interviews and "secret shoppers". I have actually used this at my

own businesses to make sure our own employees are meeting our guest service standards.

Instead of informing guests that they have no recourse for complaints or overcharges, a website could be set up for people to log their complaints and a committee could review them.

We are nearing the end of the rental season, but I was so appalled by what I learned today, that I felt the need to speak out.

Lastly, I am aware that Mr. Laughlin owns the property that [REDACTED] is leasing. I have had nothing but the best experiences dealing with both Mr. Laughlin and Mr. Newman and hold them in the highest regard. It is an honor to do business with them and I feel it is my obligation to let them know what is going on.

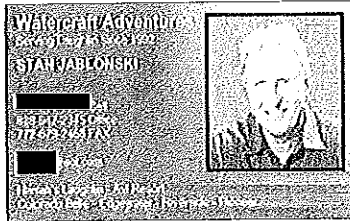

In November 2015, two special actions were filed in the Arizona Court of Appeals in *Simpson v. Miller* (CA-SA 15-0292), and *Martinez v. Steinle* (CA-SA 15-0295). Both petitions challenge the constitutionality of Arizona Constitution Article 2 § 22(A)(1) and A.R.S. §§ 13-3961(A)(3), (4). On December 8th the Court of Appeals consolidated the cases. The Superior Court's orders and the pending petitions for special action are attached to this email.

Pursuant to the Court of Appeals' December 8th Order, we are hereby providing you with a Notice of Claim of Unconstitutionality (also attached). A process server will deliver physical copies of these documents to your office later today.



for Law Enforcement Recordings

AACOP and ALELAA recognize that Arizona State Library, Archives and Public Records (LAPR) personnel have expended substantial effort to create a law enforcement records series to cover records that will be created by law enforcement agencies' use of body-worn cameras. While the proposed retention schedule was well-considered, it does not adequately take into account the day-to-day realities faced by law enforcement agencies that must store and manage huge amounts of data created by body-worn and in-car cameras. For example, it is neither realistic nor desirable to mandate, by way of a retention schedule, that every video created with this equipment be viewed prior to any final disposition or destruction of the record. The adopted retention schedule must strike a balance between the public's right to access public records, law enforcement and prosecution needs, and the burden on taxpayers for the costs of retention and management of voluminous video records.

Because of the day-to-day and long reaching implications for law enforcement of the retention schedule, we have drafted an alternative retention schedule that addresses law enforcement's needs while preserving the spirit of LAPR's proposed retention schedule and considering stakeholder concerns expressed during the work group sessions. Our changes are summarized below.

- We modified the first paragraph of LAPR's proposed schedule to more accurately describe the records intended to be covered without referring to specific technology. Current technology may be obsolete within a few years and other technological tools may become available for law enforcement use.
- We deleted language discussing Arizona's claim statute (A.R.S. § 12-821.01) because, while accurate, it is not necessary to the retention schedule and other retention schedules do not contain similar statutory citations and explanations.
- We removed references to CCTV and license plate readers. These recordings are addressed by other record series and law enforcement has not experienced any ongoing issues with the current retention periods.

Leaving those types of recordings in their existing series simplifies the new record series, making it easier for the public to reference and understand.

- We removed policy language that did not further the public interest and is more appropriately determined by each agency in implementing the retention schedule. We also deleted conclusory language about what is or is not considered evidence. That conclusion should be left to each agency to determine on a case-by-case basis.
- We simplified the schedule to make it easier for law enforcement to apply and for the public to understand. We divided recordings into two categories: evidentiary and non-evidentiary. Evidentiary recordings must be retained until the disposition of the underlying case (disposition is defined in the Remarks column). Non-evidentiary recordings must be retained for 185 days. 185 days is a good minimum retention period for recordings that are not specifically related to an ongoing investigation or prosecution. This retention period is tied to the Legislature's determination that 180 days is an appropriate time frame to satisfy the public's interest in filing claims against public entities, it promotes open government, and it allows police agencies sufficient time to confirm whether any claims have been filed.

In short, our proposed schedule is streamlined for ease of application and understanding by police agencies and citizens, and follows a similar format to other police record series.

For the above reasons, AACOP and ALELAA jointly propose the attached retention schedule for law enforcement recordings and request that it be considered.

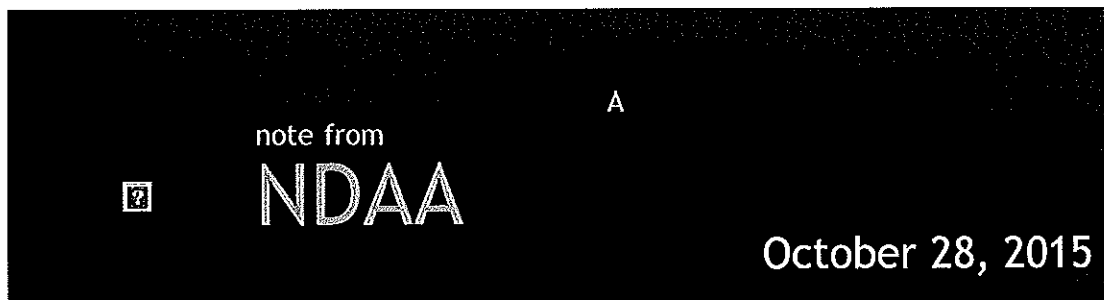
