Why did AG Brnovich reverse approval to indict Snell & Wilmer attorneys? Enclosed you will find a video created from a presentation (almost 3 hrs. long) that was the result of a lengthy investigation completed by the Special Investigation Section ("SIS") of now AG Brnovich's Office (but the investigation had been approved under AG Tom Horne).

The presentation was used by SIS Special Agents and Prosecutors to ask for final approval from now SIS Chief Prosecutor Don Conrad to seek indictments (the potential of which had been realized and approved by AG Tom Horne and his SIS Chief Prosecutor Andrew Pacheco when the investigation was authorized) from the Arizona State Grand Jury for crimes discovered in the investigation. The SIS Chief Investigator endorsed the results of the investigation, signing-off on his Special Agents' report. As well, he attended the presentation by his Special Agents to now Chief Prosecutor Conrad to express his support for seeking the indictments. In their presentation, SIS Special Agents presented conclusive evidence to Chief Conrad of crimes coordinated by the general counsel for Will Graven and his various companies, Daniel Esposito (19 felony counts in total from various crimes), and three attorneys from Snell & Wilmer.

Of note is that Snell & Wilmer fought AG Investigators' Subpoena to turn-over Graven client files (which Graven had asked Snell to do). Snell's refusal required that Investigators seek a Court Order, which they obtained, to force Snell to finally turn-over the files. Snell & Wilmer attorneys have also refused to be interviewed in these matters, or to certify that they have provided all Graven client files to the AG's office.

A prosecutor previously assigned (by former Chief Prosecutor Pacheco) to the case stated in the presentation that based upon the results of the investigation, he would 100% guarantee a successful prosecution of the suspects (a guarantee this prosecutor rarely gives). This prosecutor also stated that when he first heard of the investigation, he thought there would be nothing conclusive to support the initial allegations, but that upon seeing the results of the investigation, noting the physical evidence obtained, he had completely changed his opinion, and that he now supports prosecution.

Chief Conrad had not read the Report in advance of the presentation...and he walked-out in the middle of the presentation. As Chief Conrad walked-out, he announced that Esposito should be indicted (which he has been), but that there would be no indictment of Snell & Wilmer attorneys (reversing approvals obtained under AG Tom Horne).

One must ask, why won't the now Chief Prosecutor Conrad, acting on behalf of AG Brnovich, approve indicting Snell & Wilmer for acts that are clearly criminal (and for which one of their fraud scheme co-conspirators has already been indicted)?

- Is it because Snell & Wilmer is the longtime law firm for AG Brnovich's biggest supporter? (APS) (see Conrad's in-house assignment by AG Brnovich to investigate Brnovich-APS-the Arizona Corporation Commission relationships)
- And/or is it because Chief Conrad's right-hand man, Paul Ahler, has a son that works for Snell & Wilmer?
- And/or is it due to a relationship between Conrad and Snell's criminal attorney, Michael Piccaretta? (Who Snell hired when they learned of the investigation.)
- And/or is it simply Snell & Wilmer's pervasive influence?
- And/or is it just the longstanding tradition of attorneys protecting attorneys?
