

Bethany, you should obviously keep whatever records you have.

Haritos' lawsuit, if he files one, will presumably concern the documents that Abretske has already produced to you in response to Haritos' earlier public records requests, some of which documents were not produced to Haritos. Some of those records were apparently not given to Haritos because they concerned personal matters and not matters relating to the business of this office. I assume that you, with the help of Dennis Carpenter, kept separate copies of those documents that were produced to Haritos, and those that were not produced to him. The latter will be at issue in the lawsuit if it is filed, and they should obviously be preserved.

Haritos' 12/1 request to preserve letter goes far beyond those documents, however, requesting that the Office preserve all types of electronic data. The letter goes into technical computer matters that I know nothing about. It should be forwarded to John Abretske and inquiries should be made of John as to what Office policies are with respect to the preservation and destruction of electronic data. He should be instructed that all data relating to Haritos and Scot's and others' references to Haritos should be preserved. Presumably this Office has received preservation requests similar to this one in other matters, and John may have some protocols for effecting a hold along the lines requested in Haritos' 12/1 letter.

As to many of Haritos' other demands, several of which I'll highlight in an attachment to an email subsequent to this, I really have no idea what we should be doing. I believe the Office has established a committee to develop policies related to e-discovery matters such as this, and they may be able to provide some guidance. For example, on p. 4 of his letter, Haritos asks that with respect to Teasdale, Bethany and me, our ESI systems, media and devices should be removed from service and sequestered. If we deem that impractical, we should "forensically image" those items. He makes many technical requests, and I don't know to what extent this Office would be willing to comply. Again, others with more experience than I will need to be consulted.

A couple of final comments. Haritos obviously didn't draft this. In fact, it appears to be a slightly modified version of a document that some attorney mailed to a future defendant in a federal lawsuit. In the first complete paragraph on p. 2, the letter references the Federal Rules of Civil Procedure and recent amendments to those rules. Any lawsuit alleging an agency's non-compliance with the State's public records laws should be filed in Maricopa County Superior Court, not federal court.

Second, this Office has an obligation to maintain public records in accord with State law. If someone requests public records, we have an obligation to produce them, subject to several exceptions. As far as I know, we have an obligation to produce them as they exist in the ordinary course. As far as I know, when John produced the stack of documents in response to Haritos' public records requests, he produced everything in our system as it existed at that time that was response. I think that is all that we are obligated to do under public records laws. The hard copies of what John produced represent the AG's documents that would be responsive to Haritos' public records request, and

those that we refused to produce are the proper subject of a legal challenge. In my view, this is not a typical litigation matter in which metadata and changes to metadata might be of consequence. John presumably printed off everything that existed at the time, and that is the public record. That is what Haritos is entitled to, subject to certain exceptions. Whether metadata constitutes a public record is something that I have no knowledge or opinion on; that opinion would have to come from a public records lawyer.

Finally, as to whether you should respond to Haritos' letter, I don't know if we have a policy in this regard when we get similar "hold" letters. I know of nothing obligating us to do so. While we should do all that we have to do in terms of complying with the law, I suggest that we do nothing beyond that in terms of communicating with him. His MO is to endlessly harass people, and I would not fall all over myself assisting him.

Sorry for the rambling email. Call me if you have any questions or if you think I could be of assistance in working with John Abretske. Again, if you do respond to Haritos, given my lack of knowledge re: computer technical matters and my lack of knowledge of the Office's litigation hold and e-discovery response policies (if any), you may have to get assistance from others in preparing that response.



## Re: Request to preserve electronic data

As discussed in my last email to Ms. Bethany Diaz, I will be initiating a public records lawsuit against the Arizona Attorney General's Office; therefore, I request that you preserve all documents, tangible things and electronically stored information potentially relevant to the issues in this cause. I will be filing my public records lawsuit before the end of the year. As used in this document, "you" and "your" refers to Arizona Attorney General's Office, and its predecessors, successors, parents, subsidiaries, divisions or affiliates, and their respective officers, directors, agents, attorneys, accountants, employees, partners or other persons occupying similar positions or performing similar functions.

You should anticipate that much of the information subject to disclosure or responsive to discovery in this matter is stored on your current and former computer systems and other media and devices (including personal digital assistants, voice-messaging systems, online repositories and cell phones).

Electronically stored information (hereinafter "ESI") should be afforded the broadest possible definition and includes (by way of example and not as an exclusive list) potentially relevant information electronically, magnetically or optically stored as:

- · Digital communications (e.g., e-mail, voice mail, instant messaging);
- Word processed documents (e.g., Word or WordPerfect documents and drafts);
- Spreadsheets and tables (e.g., Excel or Lotus 123 worksheets);
- · Accounting Application Data (e.g., QuickBooks, Money, Peachtree data files);
- Image and Facsimile Files (e.g., .PDF, .TIFF, .JPG, .GIF images);
- · Sound Recordings (e.g., .WAV and .MP3 files);
- · Video and Animation (e.g., .AVI and .MOV files);
- · Databases (e.g., Access, Oracle, SQL Server data, SAP);
- Contact and Relationship Management Data (e.g., Outlook, ACT!);
- Calendar and Diary Application Data (e.g., Outlook PST, Yahoo, blog tools);
- Online Access Data (e.g., Temporary Internet Files, History, Cookies);
- · Presentations (e.g., PowerPoint, Corel Presentations)
- Network Access and Server Activity Logs;
- Project Management Application Data;
- · Computer Aided Design/Drawing Files; and,
- Back Up and Archival Files (e.g., Zip, .GHO)

ESI resides not only in areas of electronic, magnetic and optical storage media reasonably accessible to you, but also in areas you may deem not reasonably accessible. You are obliged to

preserve potentially relevant evidence from both these sources of ESI, even if you do not anticipate producing such ESI.

The demand that you preserve both accessible and inaccessible ESI is reasonable and necessary. Pursuant to amendments to the Federal Rules of Civil Procedure that have been approved by the United States Supreme Court (eff. 12/1/06), you must identify all sources of ESI you decline to produce and demonstrate to the court why such sources are not reasonably accessible. For good cause shown, the court may then order production of the ESI, even if it finds that it is not reasonably accessible. Accordingly, even ESI that you deem reasonably inaccessible must be preserved in the interim so as not to deprive the plaintiffs of their right to secure the evidence or the Court of its right to adjudicate the issue.

## Preservation Requires Immediate Intervention

You must act immediately to preserve potentially relevant ESI including, without limitation, information with the earlier of a Created or Last Modified date on or after August 30th, 2012 through the date of this demand and concerning:

1. The events and causes of action that will be described in a Complaint to be filed shortly:

2. ESI could be used to support claims or defenses in this case;

3. The files and emails related to my public records request that was denied by this office.

4. Per your policy, public records can reside on employees personal computer and from the emails you provided Teasdale has public records residing on his personal computer thus they were out of the reach of your "search".

Adequate preservation of ESI requires more than simply refraining from efforts to destroy or dispose of such evidence. You must also intervene to prevent loss due to routine operations and employ proper techniques and protocols suited to protection of ESI. Be advised that sources of ESI are altered and erased by continued use of your computers and other devices. Booting a drive, examining its contents or running any application will irretrievably alter the evidence it contains and may constitute unlawful spoliation of evidence. Consequently, alteration and erasure may result from your failure to act diligently and responsibly to prevent loss or corruption of ESI.

Nothing in this demand for preservation of ESI should be understood to diminish your concurrent obligation to preserve document, tangible things and other potentially relevant evidence.

## Suspension of Routine Destruction

You are directed to immediately initiate a litigation hold for potentially relevant ESI, document and tangible things, and to act diligently and in good faith to secure and audit compliance with such litigation hold. You are further directed to immediately identify and modify or suspend features of your information systems and devices that, in routine operation, operate to cause the loss of potentially relevant ESI. Examples of such features and operations include:

- · Purging the contents of e-mail repositories by age, capacity or other criteria;
- Using data or media wiping, disposal, erasure or encryption utilities or devices:
- Overwriting, erasing, destroying or discarding back up media;
- Re-assigning, re-imaging or disposing of systems, servers, devices or media;
- Running antivirus or other programs effecting wholesale metadata alteration;
- Releasing or purging online storage repositories;
- Using metadata stripper utilities;
- Disabling server or IM logging; and,

Executing drive or file defragmentation or compression programs.

Guard Against Deletion

You should anticipate that your employees, officers or others may seek to hide, destroy or alter ESI and act to prevent or guard against such actions. Especially where company machines have been used for Internet access or personal communications, you should anticipate that users may seek to delete or destroy information they regard as personal, confidential or embarrassing and, in so doing, may also delete or destroy potentially relevant ESI. This concern is not one unique to you or your employees and officers. It's simply an event that occurs with such regularity in electronic discovery efforts that any custodian of ESI and their counsel are obliged to anticipate and guard against its occurrence.

#### Preservation in Native Form

You should anticipate that certain ESI, including but not limited to spreadsheets and databases, will be sought in the form or forms in which it is ordinarily maintained. Accordingly, you should preserve ESI in such native forms, and you should not select methods to preserve ESI that remove or degrade the ability to search your ESI by electronic means or make it difficult or burdensome to access or use the information efficiently in the litigation.

You should additionally refrain from actions that shift ESI from reasonably accessible media and forms to less accessible media and forms if the effect of such actions is to make such ESI not reasonably accessible.

#### Metadata

You should further anticipate the need to disclose and produce system and application metadata and act to preserve it. System metadata is information describing the history and characteristics of other ESI. This information is typically associated with tracking or managing an electronic file and often includes data reflecting a file's name, size, custodian, location and dates of creation and last modification or access. Application metadata is information automatically included or embedded in electronic files but which may not be apparent to a user, including deleted content, draft language, commentary, collaboration and distribution data and dates of creation and printing. Be advised that metadata may be overwritten or corrupted by careless handling or improper steps to preserve ESI. For electronic mail, metadata includes all header routing data and Base 64 encoded attachment data, in addition to the To, From, Subject, Received Date, CC and BCC fields.

#### Servers

With respect to servers like those used to manage electronic mail (e.g., Microsoft Exchange, Lotus Domino) or network storage (often called a user's "network share"), the complete contents of each user's network share and e-mail account should be preserved. There are several ways to preserve the contents of a server depending upon, e.g., its RAID configuration and whether it can be downed or must be online 24/7. If you question whether the preservation method you pursue is one that I will accept as sufficient, please call to discuss it.

# Home Systems, Laptops, Online Accounts and Other ESI Venues

Though I expect that you will act swiftly to preserve data on office workstations and servers, you should also determine if any home or portable systems may contain potentially relevant data. To the extent that officers, board members or employees have sent or received potentially relevant e-mails or created or reviewed potentially relevant documents away from the office, you must preserve the contents of systems, devices and media used for these purposes (including not only potentially relevant data from portable and home computers, but also from portable thumb drives, CD-R disks and the user's PDA, smart phone, voice mailbox or other forms of ESI storage.). Similarly, if employees, officers or board members used online or

browser-based e-mail accounts or services (such as AOL, Gmail, Yahoo Mail or the like) to send or receive potentiall yrelevant messages and attachments, the contents of these account mailboxes (including Sent, Deleted and Archived Message folders) should be preserved.

## **Ancillary Preservation**

You must preserve documents and other tangible items that may be required to access, interpret or search potentially relevant ESI, including logs, control sheets, specifications, indices, naming protocols, file lists, net work diagrams, flow charts, instruction sheets, data entry forms, abbreviation keys, user ID and password rosters or the like.

You must preserve any passwords, keys or other authenticators required to access encrypted files or run applications, along with the installation disks, user manuals and license keys for applications required to access the ESI. You must preserve any cabling, drivers and hardware, other than a standard 3.5" floppy disk drive or standard CD or DVD optical disk drive, if needed to access or interpret media on which ESI is stored. This includes tape drives, bar code readers, Zip drives and other legacy or proprietary devices.

### Paper Preservation of ESI is Inadequate

As hard copies do not preserve electronic searchability or metadata, they are not an adequate substitute for, or cumulative of, electronically stored versions. If information exists in both electronic and paper forms, you should preserve both forms.

## Agents, Attorneys and Third Parties

Your preservation obligation extends beyond ESI in your care, possession or custody and includes ESI in the custody of others that is subject to your direction or control. Accordingly, you must notify any current or former agent, attorney, employee, custodian or contractor in possession of potentially relevant ESI to preserve such ESI to the full extent of your obligation to do so, and you must take reasonable steps to secure their compliance.

## System Sequestration or Forensically Sound Imaging

I suggest that, with respect to Scot Teasdale, Bethany Diaz, and Jerry Fries that removing their ESI systems, media and devices from service and properly sequestering and protecting them may be an appropriate and cost-effective preservation step.

In the event you deem it impractical to sequester systems, media and devices, I believe that the breadth of preservation required, coupled with the modest number of systems implicated, dictates that forensically sound imaging of the systems, media and devices is expedient and cost effective. As I anticipate the need for forensic examination of one or more of the systems and the presence of relevant evidence in forensically accessible areas of the drives, I demand that you employ forensically sound ESI preservation methods. Failure to use such methods poses a significant threat of spoliation and data loss.

By "forensically sound," I mean duplication, for purposes of preservation, of all data stored on the evidence media while employing a proper chain of custody and using tools and methods that make no changes to the evidence and support authentication of the duplicate as a true and complete bit-for-bit image of the original. A forensically sound preservation method guards against changes to metadata evidence and preserves all parts of the electronic evidence, including in the so-called "unallocated clusters," holding deleted files.

#### **Preservation Protocols**

I am desirous of working with you to agree upon an acceptable protocol for forensically sound preservation and can supply a suitable protocol, if you will furnish an inventory of the systems and media to be preserved. Else, if you will promptly disclose the preservation protocol you intend to employ, perhaps I can identify any points of disagreement and resolve them. A successful and compliant ESI preservation effort requires expertise. If you do not currently have such expertise at your disposal, I urge you to engage the services of an expert in electronic evidence and computer forensics.

Do Not Delay Preservation

I'm available to discuss reasonable preservation steps; however, you should not defer preservation steps pending such discussions if ESI may be lost or corrupted as a consequence of delay. Should your failure to preserve potentially relevant evidence result in the corruption, loss or delay in production of evidence to which I am entitled, such failure would constitute spoliation of evidence, and I will not hesitate to seek sanctions. If you have not undertaken the steps outlined above, or have taken other actions, please describe what you have done to preserve potentially relevant evidence.

## OFFICE OF THE ATTORNEY GENERAL AT- WILL UNCOVERED EMPLOYEE

#### CONDITIONS OF EMPLOYMENT **EMPLOYEES HIRED BEFORE 09/29/12**

As an at-will uncovered employee you serve at the pleasure of the agency director and/or assistant director and can be dismissed at any time without cause or right of appeal. The State Personnel Rules provide a guideline for all uncovered employees. Also, as an at-will uncovered employee, the following conditions of employment apply to you:

#### **Standards of Conduct**

## A state employee shall at all times:

- Comply with federal and state laws and rules, and agency policies and directives
- Maintain high standards of honesty, integrity, and impartiality, free from personal considerations, or favoritism
- Be courteous, considerate, and prompt in interactions with and serving the public and other employees
- Conduct himself or herself in a manner that will not bring discredit or embarrassment to the state

### A state employee shall not:

- Use his or her official position for personal gain, or attempt to use, or use, confidential information for personal advantage
- Permit himself or herself to be placed under any kind of personal obligation that could lead a person to expect official
- Perform an act in a private capacity that may be construed to be an official act
- Accept or solicit, directly or indirectly, anything of economic value as a gift, gratuity, favor, entertainment, or loan that is, or may appear to be, designed to influence the employee's official conduct. This provision shall not prohibit acceptance by an employee of food, refreshments, or unsolicited advertising or promotional material of nominal value
- Directly or indirectly use or allow the use of state equipment or property of any kind, including equipment and property leased to the state, for other than official activities unless authorized by written agency policy or as otherwise allowed by these rules
- Inhibit a state employee from joining or refraining from joining an employee organization
- Take disciplinary or punitive action against another employee that impedes or interferes with that employee's exercise of any right granted under the law or these rules
- 2. Hours of Work: The agency shall determine the hours of employment for each employee. An employee may be required to work overtime to accomplish the work of the Office of the Attorney General. If you are required to work more than 40 hours in a week, and are non-exempt from the provisions of the Fair Labor Standards Act (FLSA), you will receive, for each hour over 40 worked, either 1½ times your regular rate of pay in cash, or 1½ hours of compensatory leave. Human Resources will let you know if you fall within this category.
- 3. Outside Employment: A state employee may seek employment and engage in a variety of activities outside of the employee's work for the state. However, the employee shall not engage in other employment or other activity that is not compatible with the full and proper discharge of the duties and responsibilities of state employment, or that tends to impair the employee's capacity to perform the employee's duties and responsibilities in an acceptable manner. An employee who desires to engage in other employment or currently is engaged in outside employment will notify the employee's supervisor and complete the appropriate notification forms found at <a href="https://sharepoint.azag.gov">https://sharepoint.azag.gov</a>. The agency will review outside employment notifications for approval.
- Disclosure of Conflicts of Interests: Employees shall disclose actual or potential conflicts of interest related to outside employment activities or any other reason as soon as the employee becomes aware of the conflict by completing the Conflict of Interest Disclosure form found at <a href="https://sharepoint.azag.gov">https://sharepoint.azag.gov</a>. The agency will determine if a conflict or potential conflict exists.
- 5. Political Activities: State law restricts political activities for uncovered employees.
- Alcohol and Drug Free Workplace: State agencies shall prohibit the manufacture, distribution, dispensation, possession or use of alcohol, illegal drugs, unauthorized drugs, inhalants, or other unauthorized controlled substances during an employee's working hours or while on state premises or worksites, including state vehicles and property leased to the state. A state employee shall not be impaired by alcohol or drugs while on duty.
- Retirement: Employees must participate in the Arizona State Retirement System (ASRS) or Public Safety Retirement System (PSPRS), dependent upon the classification of the employee's position. Retirement deductions may vary

from year to year and there is an initial 27 week waiting period for ASRS (with the exception of current ASRS members). A.R.S. § 38-711(23)(b) defines a member of Arizona State Retirement System (ASRS) as a.) someone who is engaged to work at least twenty weeks in each fiscal year and at least twenty hours each week (referred to as the 20/20), b.) Have been hired with the intention to work in a capacity that meets 20/20. For new employees that meet this definition, ASRS membership and contribution is required. Contact Human Resources if you have any questions regarding this information. Special Agents make application to participate in PSPRS unless the employee has retired from PSPRS. There is no waiting period for PSPRS. If an employee in a Special Agent position has retired from PSPRS, the employee will be required to participate in ASRS per A.R.S. § 38-727(2).

#### **BENEFITS**

#### Health:

Uncovered employees who work 20 hours or more per week are eligible to participate in the State's health, dental, life and disability income insurance programs. There is no waiting period to receive ADOA administered benefits. New employees have 31 days from their date of hire to elect benefits. Benefits become effective the first of the pay period following receipt of a completed benefit enrollment form. For employees who are state agency transfers (that do not have a break in service) and are already participating in the State's health, dental, life and disability income insurance programs, your current elections and premium deductions will continue without interruption.

#### Leave:

Provisions for leave time are outlined in the State Personnel Rules, Article 6. Uncovered employees are eligible to accrue and carry over annual and sick leave, as follows:

1. Annual leave

Hours Per Pay Period

Any amount of years prior to 09/29/12

Annual leave accumulated in excess of 320 hours as of the end of each calendar year shall be forfeited, unless an exception is authorized by the Director of the Arizona Department of Administration.

2. <u>Sick Leave:</u> Sick leave for uncovered employees shall be earned at the rate of 3.70 hours per pay period, and the amount of leave carried over from year to year shall be unlimited. Sick leave is pro-rated for less than full time employees.

Uncovered employees do not have the right of appeal to the State Personnel Board if disciplined or dismissed.

I have received, read, understand and agree to abide by these conditions of employment and benefits associated with my status as an at-will uncovered employee. I understand that this list is not inclusive and that my conditions of employment also include compliance with the laws and personnel rules of the State of Arizona, and the regulations and operating procedures of the Office of the Attorney General by which I am employed. I understand this document does not add anything to or take anything away from the State Personnel Rules. In case of a conflict between this document and the State Personnel Rules, the State Personnel Rules control.

I understand that this information regarding my employment may in the future change in accordance with legislative enactments, changes in the personnel rules and/or management decisions. I understand that these changes can occur without my consent.

Dear Lt. Munley:

As you know, MCSO referred this matter to our office's Special Investigations Section (SIS) on or about March 19, 2014, arising out of allegations of unauthorized use of MCSO's logos and the Sheriff's name by the above Posse members. Because MCSO is a business victim in this case under the victims' rights law, I wanted to inform you of our office's intent to decline prosecution.

Special Agent Frank Griffits devoted a great deal of time to this matter. Based on his investigation, there does not appear to be probable cause to pursue a criminal action in regard to your complaint. It appears to be a civil matter.

Agent Griffits also pursued another issue of which he became aware that was not part of your complaint, which pertained to the use of funds in the Sheriff's Posse account, in which Ms. Hill was involved. Based on Agent Griffits' investigation, there does not appear to be any misuse of those funds. It is my understanding that Ms. Hill was removed from that Posse, but she apparently has retained some control over the Posse account. I am informing you of this, because that may involve an MCSO administrative matter. Obviously, that is not a criminal matter, and we cannot get involved in that. Agent Griffits can provide you more details about this account.

This case was indicted today by the Grand Jury. SIS will be attempting to locate her. Once she is arrested, the Office of the Auditor General will be issuing their report. The following is a synopsis of the facts if our office wants to issue a press release when she is arrested:

Tolleson Union High School District (District) alleged financial misconduct by Brenda Busse, the former bookstore manager of Tolleson Union High School (TUHS). The allegations are that Ms. Busse stole

customer cash payments made at the TUHS bookstore and used them for her own personal purposes by manipulating computer dates to conceal her actions. The monies that were stolen were monies paid by parents, students, and other individuals for various fees and extracurricular activity tax credit donations. This money should have been deposited into the District's accounts. The State alleges that Ms. Busse obtained \$120,707.65 between July of 2007 and June of 2011. On December 14, 2015, the State Grand Jury indicted Ms. Busse on one count of Fraudulent Schemes and Artifices, Theft, and Misuse of Public Monies.

Mark,

As you know, SIS admin staff fingerprints all AGO applicants as part of the application process and then sends the fingerprint cards to DPS as part of the background check. It sometimes takes 4-6 weeks for the results to come back, and by that time, some of the applicants have already started working for the AGO. Usually, the response from DPS is favorable so no action is needed. However, occasionally we get records back that reveal a possible lack of candor on behalf of the applicant. When this happens, the SIS admin staff gives the results to us for review. This usually takes the form of a stack of documents including a 10-print card, the applicant's completed application, several pages of criminal justice records, and a post-it note from SIS admin staff that reads something like, "Did not disclose," which refers to some criminal conduct that the applicant did not disclose on his/her application. Having reviewed several of these since Andy's departure, the most common acts that applicants fail to disclose are DUI and POM.

The above process revealed what I believe is an incomplete question in the "Background Investigation Certification Form" (attached). It currently asks, "Have you ever been convicted of..." [a misdemeanor or felony]. When it should read, "Have you ever been arrested for, charged with, or convicted of..." [a misdemeanor or felony]. This change will force the applicant to be more thorough when answering the question.

SIS admin staff have made the change to the form, but I wanted to seek your input/approval prior to distributing the new form to HR. Thanks.

In the BRC case we have remaining two different categories of remains to deal with. This message and the attached messages and quote are regarding around 141 sets of abandoned cremains of BRC clients. BRC had these in a storeroom and we seized them. Arizona law allows for the remains to be spread or placed into an ashuary after one year of waiting for families to claim the cremains, all of these remains are well past the one year mark. Messinger has provided a quote to inter the cremains in their Scottsdale ashuary (photo attached). I met with Messinger Friday afternoon and they will honor the December 2014 quote as is. I provided a copy of the contract agreement addendum that Jerry provided for their legal staff to review. The CEO Nancy Keil said she had no issues with the addendum and signed the form. The advantage of having licensed funeral directors manage these and other remains ensures that state law and professional industry standards are followed.

On a last note, Messinger told me they were very appreciative of our hands-on work with them. Apparently in 1994 the AGO asked Messinger to handle some remains from another case involving Brown Colonial and never provided a final release. Messinger has been holding the remains since 1994 waiting to dispose them according to state law. I hope to get this resolved rather quickly for Messinger.

Subject: Startling turn of events in Colorado City today.

To those watching what is happening in Colorado City/Hildale; Background:

Seth Cooke, Ron and Jinjer Cooke's brother, and brother-in law, had an agriculture lease agreement, along with Patrick Pipkin, from the UEPTrust, on 12 acres of land down by and along Short Creek, commonly known as the FMJ Zoo. It was properly signed by the UEPTrust's fiduciary, Bruce Wisan, and was a legal and binding contract, duly authorized by Judge Lindberg, whose court oversee's the United Effort Plan Trust.

There were people on the Zoo property without the permission of the UEPTrust, who owns the property. Consequently, Seth and Patrick legally posted the property, on all the gates and in many places on the Zoo's fences, with a "Notice to Vacate" in five days, as is done typically with commercial property in Arizona and according to the Arizona statute.

That time was legally up yesterday.

The end of the notice had this wording, "If you have any questions regarding this demand, please contact Prairie Farms LLC. We would like to talk to the occupants and see what your needs are and work something out with Prairie Farms LLC".

Since it appeared this morning, that there were still people there who hadn't contacted them in the last 6 days, though some had left, and since they had seen someone moving a fridge into the zoo, along with other belongings of a residential nature, and putting it in the tack shed, they called the Mohave County Sheriff's Office for help in enforcing their "Notice to Vacate".

Sergeant Nelson put together a task force of three Mohave County Sheriff's officers to enforce the demand. They met with Seth and Patrick, who had Andrew Chatwin there videoing everything that went on. They had some issues that have yet to be resolved, but

they are a separate incident.

The important thing, is that when the Mohave County officer's left, everything was resolved. Seth and Patrick ended up giving Verelyn Young and his crew 3 hours to remove their private property, in addition to the 5 days they had already had. The flds man, Chad Johnson, claiming to be residing in the tack shed, worked out an agreement with Seth and Patrick to live in the shed etc..

Mohave County Sheriff's Officer's then cleared everyone out that wasn't supposed to be there and left the scene as it should be, so that Seth and Patrick could lock up their gates.

About 5 hours later, I was informed by Seth Cooke, that the entire watering system for the 12 acre property had been ruined and stolen during the 3 hours they had let the flds people there remove their personal property. I informed Bruce Wisan of the fact. Since this was an actual loss to the UEPTrust, he authorized me to investigate and document the theft of the water system, and any other vandalism, and turn it into the cops. I was to press charges for the violation of Judge Lindberg's injunction order, as well as destruction and theft of the property etc.. This was about five hours after Seth and Patrick had control of their property and everyone had left. They were fixing fences and securing their property with padlocks on the gates etc..

## This is where it gets rather bizarre:

I arrived and looked at a small bit of the vandalized water system with Seth Cooke, Andrew Chatwin and Patrick Pipkin. It was bad and looked like the damages were going to be in the \$1,000.00's of dollars. I then called the local police and officer D. R. Barlow was dispatched to the property to investigate the crime.

When he got there, rather than go with me and take a report of the ruined water system and stolen equipment, he told me he was going to arrest me. He said that Seth Cooke, Patrick Pipkin and Andrew Chatwin were all right to be there, but that I wasn't, and said I was trespassing. He said that Seth, Patrick and Andrew were guests of Chad Johnson, but that as "Guests", they had no right to invite me (I work for the Special Fiduciary who works for the court, essentially, the property owner) onto the property.

I called Mohave County dispatch and asked them to send at least one officer back to the property to help resolve this new conflict, instigated entirely by the Colorado City Marshal, D.R. Barlow. At the same time, this officer called his chief of police, Jerry Darger to find out what to do next.

When the Mohave County Sheriff's officer arrived (officer Portillo), he explained to the local city officer all that they had gone through this morning (he was there on the scene the

entire time), but the local officer wouldn't accept the Mohave County Sheriff's Office determination that the zoo was commercial property. He wanted to keep talking to his chief of police, Jerry Darger, to get a different determination.

As our officer turned to go talk to his sergeant, officer Nelson, who had been there the whole morning with his task force, officer D.R. called his dispatch for police backup. Our officer spun around and said something like, "You realize we are on the same side don't you"? He then called Mohave County for back up, as I understood it.

Later, officer D.R. and officer Portillo explained to each other again the way things really were. I had clearly talked to D.R. about the letters from County Attorney James Schoppman concerning commercial property, but he would have none of those letters. He didn't have any interest in what the Mohave County Sheriff's Office and it's legal counsel had determined.

Officer Portillo then said that they (the two officers), would just have to agree to disagree. He said that Mr. Wyler has every right to be here at this property and asked officer Barlow if he was going to investigate the vandalism or not and take Mr. Wyler's report. He also got his sergeant, officer Nelson, on his speaker phone, who clearly told officer Barlow that his officer was taking the correct position on this matter.

Officer Barlow began the investigation of the damaged property. On the first little pasture we documented 35 sprinklers stolen and many of the pipe stands destroyed, as well as freshly destroyed sprinklers etc.. About then, 3 Washington County deputies arrived as back up for officer Portillo and local chief of police , Jerry Darger, arrived as backup for officer Barlow.

Shortly after that, another Mohave County officer, deputy Macia, arrived as backup for officer Portillo as well. Chief Darger said he was going to uphold his city attorney, Ken Brendel's position, that not only was Isaac trespassing, now Seth, Patrick and Andrew were trespassing as well. He said if we didn't leave now, he was going to have us all arrested. Officer Portillo said that he called his officer in charge, and he had said that they were not going to stop the local cops from arresting us, but that if we were arrested, they would gather evidence and be witnesses in the case, then told the local cops that their counsel was to **not** arrest any of us.

I called Bruce Wisan, owner of the property, and the man I work for. I told him the situation and that I was willing to be arrested if the local cops pushed it that far. Bruce basically told me that this type of egregious behavior by the local cops was going to be addressed by the D.O.J. and to let the local cops run me off the property, and stop me from being able to document the vandalism damage to the UEPTrust property etc.. He said he didn't want

me arrested (essentially, this was all over a tack shed that wasn't worth the wages of the officers involved in the incident that day ).

I told Bruce I would leave if the local officers told me too, even though the Mohave County Sheriff's officer's were saying I had every right to be there. Officer Jerry Darger then told all of us (Seth had already gone outside the fence by then to get paperwork for the officers) to leave the property or be arrested. I took my video camera and spare batteries from Andrew and left the property as requested, even though I knew it was wrong of them to request it of me.

Then I come back to the outside of the fence and continued to ask questions and present our argument from outside of the fence. I asked D.R. if he was recording all this, because I told him that the last time I was at an arrest like this (the Emil Fischer case), they had turned **off** their recorders. I knew, because the next day, when I requested the recording from the local police department, through a "Freedom of Information Request"; They said there was no recording. This is highly irregular, because they always record my interactions with them.

DR admitted to me, in front of the Mohave County officers, that he had turned off his recorder a while ago. I then asked him to turn it back on, as this arrest unfolded. He wouldn't say he would or wouldn't. I presume he didn't, even though he walked away.

I then witnessed and videoed officer's Jerry Darger and officer Daniel Roy Barlow arrest, first Andrew Chatwin, then Patrick Pipkin, for not leaving their property. I didn't hear the officer's reading them their Miranda rights, but they may have done it in the separate police vehicles, after they were cuffed, or on the way to to what we assumed was Purgatory Jail, in Utah.

I also witnessed the Mohave County Sheriff's officer's gathering evidence and videos of the arrest etc..

These local police officers took the word of an flds man, Chad Johnson, (Andrew's brother in law), claiming to be living in the zoos tack room, who couldn't prove an occupancy agreement from the Trust to live there, couldn't prove the water, or power, was in his name, wouldn't say who authorized him to be there at all, and couldn't prove that he had any right of any kind to be there at all. Additionally, they had the word of Seth and Patrick that a fridge had been brought in the previous day at 2:30 pm, and another lady saw them bringing personal items to the tack room when she was picking her children up from school yesterday.

They took the flds mans word over someone with full documentation, and proof they were

shown, of every single legal step they had gone through to be there at this time. They also went against direct admonition from the Mohave County Sheriff's officers, that they shouldn't make this arrest.

Then I videoed local officer Curtis Cooke overseeing Streamline Automotive impounding Andrew's truck and hauling it away, to an impound yard I presume, while officer Portillo witnessed it. I also videoed Seth Cooke giving officer Cooke a key to their gate.

I later found out, through private investigator Sam Brower, that Andrew and Patrick had been booked into the Purgatory Jail, and wouldn't be able to face the judge until the next morning.
