On December 4, 2020, I traveled to San Luis, Arizona with SA Geisler. The purpose of the trip was to attempt to speak to Guillermina Fuentes regarding the video taken on August 4, 2020 during the primary election. Geisler and I arrived at Fuentes' address of Upon arrival, I knocked on the door and Fuentes opened the door. I recognized Fuentes from previous contacts with her. I asked if we could come inside and speak to her and she invited us in. The interaction with Fuentes was audio recorded.

Once inside, I set up my Surface Pro and loaded a thumb drive I had brought with me. The drive contained the video taken by Gary Snyder on August 4, 2020 at the Cesar Chavez Cultural Center during the primary election. I queued the video to a point where Fuentes was observed interacting with Alma Juarez and sealing a ballot envelope she received from Juarez.

I showed Fuentes the video and asked her what was occurring in the video. Fuentes stated that she Juarez had asked her to check the ballot to make sure it was completed correctly. She stated the ballot was that of Alma Juarez's sister. As the video continued to play, Fuentes explained that she checked the ballot and sealed the envelope. I then asked her why she was removing several more ballots from a folder on the table. Fuentes stated that those ballots were those of her husband and her mother. I suggested that there were more than two ballot envelopes removed from the folder, Fuentes denied that there were more than two.

I then asked Fuentes why Alma carried the ballots into the polling place if they were the ballots of Fuentes' husband and mother. She replied, "because she is going to the polling place". I questioned why Fuentes would not have deposited the ballot envelopes as she had been at the polling place all day. She stated that she needed to be at the table because people stop by and "need advice".

As we continued to talk about the video, Fuentes stated "if you notice, I took the ballot...and I didn't do anything or write anything on the ballot. You cannot say that I was writing. What they are claiming is that I vote the ballots of some people." Fuentes was asked who was claiming that she voted people's ballots and she stated it was the people that "do not like us".

Fuentes went on to explain that she and those that work with her get people to go to the polls and vote. She advised that they call people on election day and tell them to come to the polls and vote. She stated that she does ask people to support the candidates that she supports. Fuentes stated that she does not "force" anyone to vote.

Fuentes stated that Alma Juarez and her sister Hilda are her friends, and that Alma is also her neighbor. She stated that Alma and Hilda never used to vote, and she advised them that they "have to vote". Fuentes stated that Alma and Hilda told her that they did not know who to vote for. Fuentes stated that she "educated" them.

Fuentes stated that those that oppose her come after her because by "killing the head honcho they kill everybody".
