This supplement is in place of Supplement #11 which had been entered in error and not of this investigation.

On February 2nd, 2021 Yuma County Recorder Robyn Stallworth Pouquette was interviewed by phone. The interview was digitally recorded and attached to this report. The following is information learned from Robyn.

Robyn was asked about the changes in the ballots as names did not appear in the same order for each ballot. Robyn stated that depending on the precinct the candidate's names will rotate for equal distribution.

Robyn was asked about labels placed over voter information with other voter information. Robyn stated this should not happen but may be explainable. Based on the photos it appears as though the voters are related and signed the wrong envelopes which were later corrected.

Robyn reported there have been rumors over the years that a group of people sometimes led by Guillermina have collected signed ballots where voters were told the group would complete the ballot correctly. Robyn stated this was common practice until the ballot harvesting law went into effect. Robyn stated this group now waits at the polling place for people to bring them the ballot.

Robyn confirmed at the polling place there is a box for early ballots. Robyn confirmed there is a voting inspector at the polling place to ensure voters are there either for the early ballot box or live voting. Robyn said they have found that some people want to place their ballot in the box without the envelope.

Robyn was asked about the voter list from her office. Robyn stated her office does release this list to the chairpersons of the political parties who in turn release the lists to various groups. This would allow them to contact potential voters. The chairpersons would know who the lists were released to.

Robyn talked about voter issues in the past and complaint she made about the voter fraud. Robyn stated even the FBI has conducted investigations in the past.

Robyn was asked if there was a way to determine how many times a person had come in and deposited ballots into the box. Robyn stated there is no video. Robyn stated that the inspector Matthew Randall told her that the same people to include Guillermina came into the polling place to drop off ballots.

Robyn said Guillermina was with another older lady who was asking to assist voters inside the poll. Voters were told to tell the poll pad judges they were there to help them. Robyn said this is why they trained the poll pad judges to have the assistants sign.

Robyn stated that on Election Day Guillermina and others did assist 18 voters with voting in the polling place. Robyn said that voter assistants must sign when they assist a voter. Robyn said some of the people assisted did not need the assistance and permitted the assistant to vote. Robyn forwarded the list of voters who were assisted at the polling locations for 8/4/2020. (Attached) Robyn said they provide assistance to voters who request it inside the polling location. Robyn said their assistants speak both English and Spanish. Robyn later provided the following Inspector and Marshall information for the Vote Center in August:

Cesar Chavez Inspector: Matthew Randall. Cesar Chavez Marshal: Blanca Arce,

Robyn was asked if there is any reason a voter would deposit ballots or enter the voting place more than once. Robyn said no. Robyn had no other information to provide and the interview was concluded.
