On December 4th, 2020, during an interview with Special Agent Knuth, Guillermina Fuentes was asked about ballots she removed from a folder on the table where she was seated at. Fuentes stated these ballots were to her husband and her mother.

On March 30th, 2021 the following request was emailed to Yuma County Recorder Robyn Pouquette.

"Can you please provide voting information on Guillermina Fuentes and her husband Carlos Aguay Fuentes SR. Their address is I am looking for when their ballots were mailed to them and when they were received back to be counted. These ballot were not in the August ballot box."

On Friday April 9th, 2021 Pouquette emailed the following information pertaining to the request for information about Guillermina Fuentes ballots.

"Mr. Fuentes' ballot was automatically sent a ballot because he's on the Permanent Early Voting List on the first day of voting (7/8/20) and ballot was returned, verified, and accepted on 7/27/20.

Guillermina Fuentes was sent a ballot on 7/8/20 as well (she's not on PEVL but made a single ballot request for that election) and she did not vote the requested ballot but walked into the Vote Center at Cesar Chavez Cultural Center on the morning of the Primary Election and signed into the poll pad and received a regular ballot that was tabulated when she voted. She signed-in at 6:11 a.m. that morning to get a ballot."

Based on the information from Robyn, Mr Fuentes Ballot had already been returned by mail and received prior to the August Primary Election.

On December 4th, 2020 Fuentes was shown the video obtained by Snyder of her sitting at a table accepting a ballot from Alma Juarez. Fuentes reported that she had received the ballot from Juarez to ensure its accuracy and completion. Fuentes stated she had not written on any ballot and that it would have to be proven to her.

On December 15th, 2020 Fuentes was again shown the video of her accepting the ballot from Juarez. The video continued showing Fuentes writing on the Ballot envelope and then removing the ballot from the envelope and writing on it. Fuentes then stated she does not remember this and perhaps "finished voting something."

Based on video depicting Fuentes writing on or completing a ballot of another voter, and her statement supporting this fact, a charge of knowingly marks a voted or unvoted ballot or ballot envelope A.R.S. 16-1005(A) is being submitted for review of prosecution.
